An objection must be made to the responsible authority in writing, include the reasons for the objection and state how the objector would be affected. The responsible authority must make a copy of every objection available for any person to inspect free of charge until the end of the period during which an application may be made for review of a decision on the application. The responsible authority will not decide on the application until at least 14 days after the date on which the last notice is given. If you object, the responsible authority will tell you its decision.
